Additionally, provide photos that the RMGA can post on social media, or otherwise disseminate to RMGA membership. These will be reviewed by the RMGA and the Science and Conservation Committee and may be used to showcase or in of different RMGA member outreach and social media efforts. This is in addition to any publishing efforts pursued or required of the applicant by other funding sources and/or sponsors. Final reporting is due to RMGA by the end of the next funding period after conference conclusion.

RMGA reserves the right to share all materials submitted with credit to the applicant and may at times, seek follow-up information to address member or agency inquiries and to keep informed as RMGA is interested in learning from applicants' experiences.
